CLASSES OF AWARD

- Major Awards:** named in the outer rings, are the principal class of awards made at a level
- Minor Awards:** are for partial completion of the outcomes for a Major Award
- Supplemental Awards:** are for learning that is additional to a Major Award
- Special Purpose Awards:** are for relatively narrow or purpose-specific achievement
- Professional Awards:** these are for occupation-orientated qualifications including apprenticeships

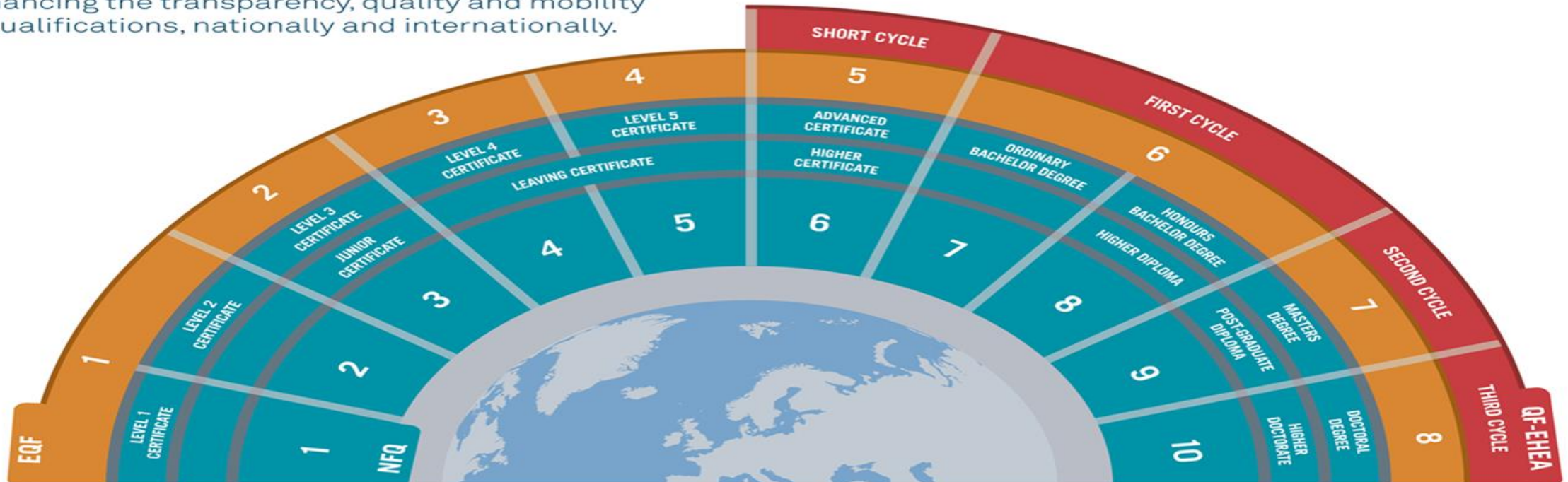

Qualification Types and the NFAQ



- **MAJOR** qualifications (including Bachelor, Master, Doctorate)
- **MINOR** qualifications (for partial completion of the outcomes for a Major Award)
- **SPECIAL PURPOSE** qualifications (for relatively narrow or purpose-specific achievement)
- **SUPPLEMENTAL** qualifications (learning that is additional to a Major Award)

- 6,092 higher education programmes
- 1,326 higher education qualifications with ≤ 30 ECTS – can be classified as **micro-credentials**

Micro-credentials and Quality Assurance



- Public HEIs are **self-accrediting**
- National QA arrangements consistent with **European norms and standards**
- **Learning outcomes** approach well implemented
- Development, design, delivery, assessment, certification and review of qualifications, all in **QA scope**.
- **NFQ, including policies on access and progression, integrated into QA** arrangements
- Application of mainstream QA to MCs raises questions about **proportionality, consistency and pragmatism**.

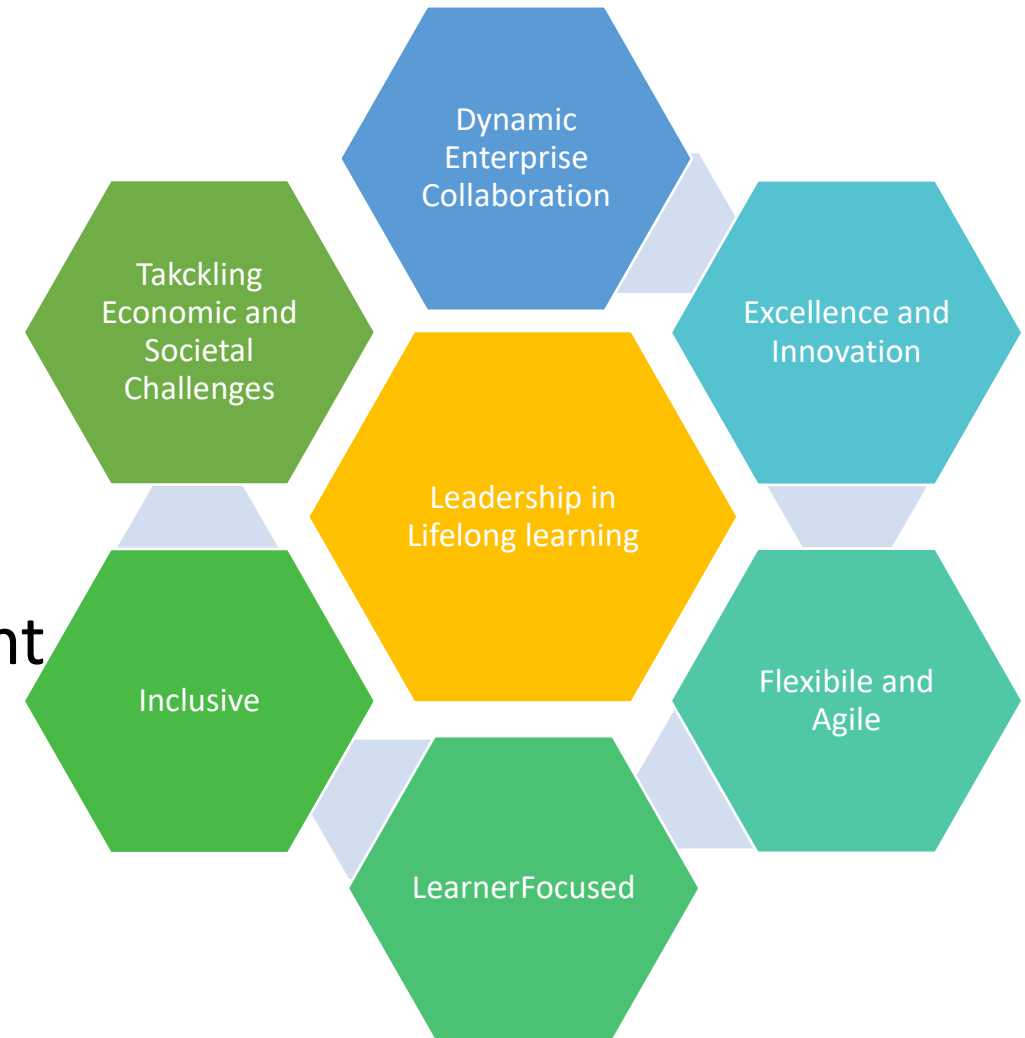
